## **Vehicle Dealer License - California DMV**

Yes, per C.R.S. 44-20-119 "Should the motor vehicle dealer or used motor vehicle dealer change the site or location of such dealer's principal place of business, such dealer shall immediately upon making such change so notify the board in writing, and thereupon a new license shall be granted for the unexpired portion of the term of such license at a fee established pursuant to section 44-20-111.

## **Licensing - Auto Industry Division | Department of Revenue ...**

Take Note. HB 1667. House Bill 1667 was passed during the recent 86th legislative session. Beginning 9/1/2019, a GDN Motor Vehicle, Motorcycle, Travel Trailer, or Utility Trailer/Semi-Trailer license holder will be able to operate at the same locations as a Salvage Vehicle Dealer/Rebuilder without a separate Salvage license.

## **TXDMV.GOV - Dealers**

Motor vehicle dealers must electronically update their dealer license information using the Motor Vehicle License Portal. A new insurance certificate must be provided for the new location. Retail dealers must also furnish photographs of the new location and signage.

The Tennessee Motor Vehicle Commission is committed to the uniform and impartial application of the Tennessee Dealer-Manufacturer Licensing Laws, Rules and Regulations. These regulations are intended to empower consumers while allowing all dealers to compete for business on a level playing field.

## **Tennessee Motor Vehicle Commission**

A GDN is the basic dealer license that allows a person to buy, sell or exchange the type of used vehicle for which the GDN is issued. GDN licenses are divided into several categories. When applying for license, you must select one of the independent license types on the application.

## **Independent (GDN) License - TXDMV.GOV**

Per A.R.S. § 28-4407, submit a written notice of any change in business hours to Dealer Licensing at least ten (10) days prior to the change. Cancel Your Dealer License Submit a notification signed by an owner that includes the dealership license number, business name and effective date of the cancellation.

\*A current valid franchise for each type of new vehicle must be on file with the Dealer Licensing Unit prior to the sale. Dealer Licensing. Doing business as a vehicle dealer, manufactured home dealer or vehicle salesperson requires a license in Kansas. Once established with a license in Kansas, all dealer transactions are handled online through the dealer portal that can be accessed by logging into the Kansas Department of Revenue Customer Service Center.

## **Kansas Department of Revenue Division of Vehicles - Dealer ...**

If you sell vehicles to other licensed dealers only, you need a Wholesale dealer license. To qualify for a retail dealer license you must meet all of the following requirements: A permanent business location—not a residence—with office space, a 12x20-foot indoor vehicle display area and an adjacent display lot.
